

# Wadebridge Town Council



# Minutes of the Full Council meeting held on Wednesday 9 October 2019 at 7pm in the Main Hall, Wadebridge Town Hall

## 1149/19 Public Participation

- Report from Cornwall Councillor :
  - > Cllr Knightley (Wadebridge East) advised the following:
    - Anti-social behaviour in the park area He is aware of issues with teenagers gathering near a property and has received correspondence regarding this. The teenagers have an intimidating nature and have been discussed previously for similar reasons. Cllr Knightley said he understands that this is not the Town Council's responsibility.
    - Planning application on the Sainsbury's site The affordable housing quota is now only 25% which is lower than expected. Aware that the Town Council will be consulted as a neighbouring parish. Cllr Knightley said that he had thought that the affordable housing quota was to be 100% and he was not expecting to support this application and would call it in to committee if need be.

#### 7.05pm, Cllr Gliddon arrived.

- Old Bakery site There are safety issues with the site as youngsters are breaking in and causing problems. The proposals may help to solve these issues.
- Tower Hill There are issues with residents using bollards to stop others parking in the area. There are no parking restrictions in that area and has asked families to stop using bollards.
- Wadebridge West work load Confirmed that he is taking the work load for Wadebridge West until after the election.

The Mayor advised Cllr Knightley that Members may have questions regarding the Old Bakery site at agenda item 9.a.v.

There was a brief discussion regarding the following:

- Safety issues with the Challenge Bridge including a report that railings are now loose. Cllr Knightley advised that Cornwall Council is considering removing the bridge to undertake the necessary repairs and that a feasibility study will be carried out.
- Reports of teenagers in the park area who are causing problems and being unpleasant and irresponsible. Cllr Knightley stated that he intends to speak to the younger age group at the Rugby Club as he feels it is better to be pro-active in these matters. The Mayor confirmed that these problems have been raised with the Police but that they unfortunately do not consider it as serious.

1153/19 Egloshayle, St. Breock and Wadebridge Neighbourhood Plan — The Mayor reminded Members that there is a mandate to not work with St Breock or Egloshayle parish councils until after the Governance Review. The Consultants are continuing to work on relevant documents to move the plan forward. Cornwall Council has suggested a working group is formed to consider proposals for the Bradfords Quay development and for the Place Shaping work.

## 1154/19 Planning -

- a. Applications The Mayor took this item due to apologies from both Chair and Vice-Chair of Committee. It was RESOLVED to make the following responses:
  - i. PA19/08483: Porthmeor, Elmsleigh Road, Proposed bifolding doors and raised decking to rear of property. SUPPORTED.
  - PA19/08512: 5 Mill Close, Bespoke single storey lean-to extension to be constructed to the rear of the existing dwelling. SUPPORTED.
  - iii. PA19/08803: Land North east of Copperfield, Bodieve, Reserved Matters application for the construction of a dwelling following outline consent PA19/05106 dated 13/08/2019. SUPPORTED.
  - iv. PA19/08876: 17 Westcott, Proposed utility/porch to existing private dwelling. SUPPORTED.
  - v. PA19/03451: Landmark Estates, The Old Bakery, Polmorla Road, To build a mixed development of 37 1, 2 and 3 bedroom flats, 6 shops with car parking on ground floor.

Members raised concerns with the current condition of the site in relation to health and safety. Cllr Knightley stated that he would contact Cormac regarding this. Cllr Knightley also advised that the reduced affordable housing aspect has been agreed to mitigate against additional costs incurred by the developer.

There was some discussion around the flood risk documentation and requirements for affordable housing.

 Application SUPPORTED – It was agreed to write to Cornwall Council to request that the site is made safe either by the land owner or Cornwall Council and to note that whilst members would prefer the full quota of affordable housing they are aware that Cornwall Council will ensure there is the optimum number of affordable housing on this site taking into account the mitigating circumstances.

- vi. PA19/08462: Land East of the Carpet Trader, Trevanson Street, Proposed Development of Containers for a mix of Class A useage. SUPPORTED.

  - ii. PA19/06791: Glynnhale Properties Ltd. Land East of Green Hill Villas, Green Hill, Wadebridge, Proposed residential development with new access and associated works. APPROVED.
  - iii. PA19/07480: Cleveland House, 27 Trevanion Road, Orange Circled Tree (1) Actually Shrub Pittosporum Tenuifolium removed as blocking light to 25% of garden and interfering with overhead phone lines serving neighbouring properties. This area will be re-planted with smaller shrubs. DECIDED NOT TO MAKE A TPO (TCA APPS).
  - iv. PA19/06509: St Gervais, Fernleigh Road, Removal of masonry boundary wall and excavate to form new driveway. Piers, spindles and copings of existing wall to be re-used as part of a retaining wall. APPROVED.
  - v. PA19/07613: Wadebridge Town Council, Land South West of the Camel Trail, Proposed concrete skatepark for use by varied non-motorised, wheeled sports, such as skateboarding, BMX, wheelchair and scooter. To include access from the existing Camel Trail without compliance with Conditions 2 and 4 of Decision Notice PA19/02333 dated 21 June 2019. WITHDRAWN.
- 1155/19 Wadebridge Library & Information Service The Monthly Performance Report for Devolved Sites and the Monthly Statistical Report (September 2019) were tabled and discussed. The Clerk noted several points including:—
  - An increase in business.
  - Training undertaken by the Library Manager.
  - Considering an event for Wadebridge parishioners.
  - Feedback received from the TEX session has been very positive.

## 1156/19 Wadebridge BMX Skatepark -

- i. Update from the Clerk The original hand over date has not been possible for several reasons. The completion date is now expected to be in 2-3 weeks.
- **ii.** Proposal for the bridge from the Skatepark to the Camel Trail The bridge is a requirement of the Cornwall Council lease. Revised costs are awaited along with feedback from Cornwall Council which includes a query as to whether the skatepark can be opened without the bridge in place and the condition set by Planning. Issues may arise if the bridge cannot be completed whilst the contractor is on site.
- 1157/19 Memorial Tree, Shrub & Bench Policy (circulated with agenda) It was RESOLVED to accept the policy as presented.
- 1158/19 Community Governance Review The Mayor confirmed that the revised submission was submitted and that whilst the report recommended that there be no change, Cornwall Council has since not accepted that recommendation and the Town Council await further information regarding this.
