

Wadebridge Town Council

Minutes of the Full Council meeting held on Wednesday 20 December 2023 at 7pm in the Main Hall, Wadebridge Town Hall

- Reports from Cornwall Councillors
 - ➤ Cllr Moorcroft (Wadebridge West & St. Mabyn) Cllr Moorcroft addressed the meeting on the following items :
 - Next CAT meeting is scheduled for 8 January 2024, 6.30pm and is open to the public. Details of the draft agenda were relayed.
 - Rise Meeting Details of a presentation to businesses on 22 January 2024 were advised. The meeting will take place in the Conservative Club and will concentrate on businesses within Wadebridge.
 - Cornwall Council Survey regarding Code of Conduct training details of a questionnaire to consider who has not undertaken the training is now available (closes on 3 January 2024). This has come about due to complaints on town and parish councillors.

The Mayor asked if the Town Team members will have the opportunity to speak to Rise representatives at the meeting on 22 January.

Cllr Moorcroft said he thinks there will be an opportunity later in the evening.

- Clir Mould (Wadebridge East & St. Minver) Clir Mould addressed the meeting on the following items:
 - Wadebridge School has been successful with their CIL application and funding has been awarded. This will be used on the school's sports facilities.
 - The Leisure Centres did not get funds awarded however, the next round is capital funding and it is hoped that Carn Brea, Wadebridge and Camelford will be awarded funding.
 - The Government has changed rules on DIY waste at HWRC's. This is no longer chargeable from 2 January 2024 at some sites. Details of the closure of the Launceston HWRC were relayed (upgrade works) and it has been requested that the Tintagel HWRC remains open.

Cllr Mould provided an update on the new refuse bin roll-out – Wadebridge is the third-roll out due in April or May 2024.

 - i. PA23/08632: Land North East Of 90 Egloshayle Road Wadebridge Cornwall. Variation of Condition 1 (approved plans) of Application No. PA22/00592 dated 18th May 2022 (Demolition of existing garages and proposed new dwelling with non compliance with condition 2 in relation to decision notice PA20/04717 dated 26.08.2020. SUPPORTED.
 - **ii. PA23/09240:** 1 Park Place, Whiterock Road Wadebridge Cornwall. Proposed accessible car parking and partial demolition of garden wall in conservation area. **SUPPORTED.**
 - iii. PA23/07111: 111 Egloshayle Road Wadebridge Cornwall PL27 6AG. Listed Building Consent for proposed replacement of hanging slate on front elevation with reclaimed natural slate. SUPPORTED subject to the recommendations of Historic Environment Planning being implemented.

Outline planning permission with some matters reserved to include appearance, layout and scale for demolition of an existing private residential dwelling and replace with 9 residential apartments. NOT SUPPORTED Members have concerns with the size of the development and potential overdevelopment of the site.

- iv. PA23/07551: Land South Of 53 Molesworth Street Wadebridge Cornwall PL27 7DR. Certificate of lawfulness for proposed use: Change from C3 Dwelling house (garage/storage) to the new class use E (A2 or B1A since revoked), incorporating office spaces. Granted (CAADs, PIPs and LUs only)
- v. PA23/07738: 16 Trevanion Road Wadebridge Cornwall PL27 7NZ. Proposed change of use of the dwelling to a house in multiple occupation. APPROVED
- vi. PA23/06484: The Flat 43 45 Molesworth Street Wadebridge Cornwall. Conversion of unused loft space to residential annex with staircase access. APPROVED
- vii. PA23/07838: 4A Bess Park Road Trenant Industrial Estate Wadebridge Cornwall. Storage extension to industrial unit to replace existing container. APPROVED
- viii. PA23/06611: The Holly, Trenant Vale, Wadebridge, Single storey extension to rear of property. APPROVED
- ix. PA23/08950: 92 Egloshayle Road Wadebridge Cornwall PL27 6AF, Works to a tree in a Conservation Area for Leylandii (L1) reduce height of tree by 50% following storm damage and remove completely a large branch overhanging the neighbour's garden (branch is approximately 8 to 10 metres high). Reducing crown height of tree will improve safety. Decided not to make a TPO (TCA apps)
- x. PA23/08521: 3 Eddystone House Eddystone Road Wadebridge Cornwall. Prior Approval for change of use of first and second floors from commercial to 5no flats. WITHDRAWN
- xi. PA23/07464: Land At Trevanion Road Wadebridge PL27 7DY. Outline application for proposed residential development comprising up to 30 new dwellings (including 30% affordable homes) with associated landscaping and site infrastructure (all other matters reserved); access only. WITHDRAWN
- xii. PA23/05124: Land Rear Of 84 Egloshayle Road West Park Wadebridge Cornwall. Proposed two storey dwelling on building plot to the rear of existing dwelling. APPROVED
- xiii. PA23/07165: 9 New Park Wadebridge Cornwall PL27 7PL. Rear extension incorporating a new kitchen and dining room at ground floor level and a small extension to the existing bathroom at first floor level. Minor alterations to ground floor plan to improve property layout. APPROVED
