

Wadebridge Town Council

Minutes of the Full Council meeting held on Wednesday 15 November 2023 at 7pm in the Main Hall, Wadebridge Town Hall

Housekeeping – The Deputy Mayor welcomed everyone to the meeting and advised of evacuation routes in case of an emergency (there were no hazards to note) and reminded all those present of the following:

 Police Reports – PC Bartlett and PS Gwinell introduced themselves and addressed the meeting explaining their roles within Bodmin and Wadebridge Police.

PC Bartlett provided a brief crime report and an update on new officers coming into post shortly.

There was discussion around the reluctance to report anti-social behaviour and the current situation with this especially around the bus station area. An update on this was provided and PC Bartlett stressed the importance of reporting issues so that as much information as possible is obtained in order for the Police to act.

PS Gwinell referred to the ongoing problems within town and noted that the poor lighting near band stand area doesn't help as youths now gather there because of this. He reiterated the importance that the public should report any issues where they feel a situation does not appear right.

Heavy workload and the balance of that with being out on the street and covering such a wide area was highlighted.

PS Gwinell invited councillors to join them for a ride-on which will provide an interesting perspective of Police duties. Councillors to contact PC Bartlett regarding this.

1866/23 Clerk's Report – The Clerk provided a verbal report advising the following :

- The Changing Places toilets planning application was submitted to Cornwall Council two weeks ago.
- The Finance & General Purposes Committee meeting scheduled for Monday 13 November 2023 did not go ahead as it was inquorate. This has been rescheduled for Monday 27 November 2023.
- Pantomime rehearsals are underway, and tickets are on sale now. This year's panto is Robin Hood and will take place week commencing Monday 4 December 2023.
 Councillors may be required to help at the performances - the office will be in touch for councillor availability.
- CCTV (changes to monitoring due to Cornwall Council withdrawing the Tolvaddon service) – the town council has been omitted from information on alternative options. New solutions for monitoring need to be found and some town councils are now linking together to achieve this. There is potential to join with Liskeard and Bodmin town councils who are also currently looking for alternative options. Further information will be available once there has been a discussion with them. Related costs moving forwards are unknown.
- **Finance & General Purposes Committee** Cllr Jarvis, Chair of Committee, advised the difficulties with current membership and the importance that all councillors become members in order that town council financial business can be properly transacted.

Noted that this may be an issue with the registering of the units. The Clerk provided information on related costs, including maintenance, and the town council's position with funding units. Noted that a wider discussion around locating units within neighbourhood areas may prove beneficial and it was suggested that the Cornwall Councillors may be able to assist with this. Clerk to investigate related costs for further consideration.

 - i. PA23/08521: 3 Eddystone House Eddystone Road Wadebridge Cornwall. Prior Approval for change of use of first and second floors from commercial to 5no flats. SUPPORTED HOWEVER, COUNCILLORS HAVE CONCERNS REGARDING POTENTIAL NOISE, SMELLS AND DISTURBANCE SHOULD THE GROUND FLOOR SPACE REMAIN A RESTAURANT.
 - **ii. PA23/07165:** 9 New Park Wadebridge Cornwall PL27 7PL. Rear extension incorporating a new kitchen and dining room at ground floor level and a small extension to the existing bathroom at first floor level. Minor alterations to ground floor plan to improve property layout. **SUPPORTED.**

T2 Beech: Reduce by 2.5/3 metres. T3 Mature Beech: Reduce crown by 3m. T4 Eucaplyptus: Reduce crown by 3m. T5 Oak: Thin by 20%. APPROVED
 - iii. PA22/07833: West Of The A389, The Site Is To The North And South Of Green Hill Lane. Submission of details to Discharge Conditions 4, 5, 6, 10, 11, 12, 13, 16 and 17 in respect of Decision Notice PA17/05689 dated 15th February 2018. Disch of cond not all conditions agreed

PA23/08950: 92 Egloshayle Road Wadebridge Cornwall PL27 6AF, Works to a tree in a Conservation Area for Leylandii (L1) reduce height of tree by 50% following storm damage and remove completely a large branch overhanging the neighbour's garden (branch is approximately 8 to 10 metres high). Reducing crown height of tree will improve safety. To be decided under Cornwall Council delegated authority.

This resolution is made due to the short time scale for order and installation, research carried out of the market providers and the provision of quotes informally sourced which indicate the variation in costs from contractors.
 - It was **RESOLVED** to select Rise Adaptations as supplier of the Changing Places and Toilet Unit at the price quoted of £84,000.
- iv. Councillor Communication & Engagement – The Chair of the Staffing Committee addressed councillors on the level of councillor involvement and engagement as part of the town council workload and responsibilities. Suggestions to advance this were debated. There was also discussion and suggestions on how to recruit new councillors.
