Budget monitoring figures to 31 October 2017

The figures were reviewed and it was **RESOLVED** to accept the budget figures as presented.

Fin 115/17 Precept 2018/19

Members received and discussed the 2018/19 draft Precept document (noting Agenda reference to 2017/18 which should read 2018/19).

- It was RESOLVED to RECOMMEND to FULL COUNCIL to accept a precept figure of £423,810 for 2018/19 (an increase of 10% on the 2017/18 precept figure of £385,282).
- Members noted that this Precept increase will have a corresponding 7.08% increase on a Band D property of £12.10 per year or 23p per week.
- Members also noted that the full cost of operating the Library as a devolved service from Cornwall Council features in the 2018/19 Council budget and precept.
