

Wadebridge Town Council

Minutes of the Town Council meeting held on Wednesday 11 December 2013 at 7pm in the Victoria Room, Wadebridge Town Hall

Housekeeping – The Mayor advised of evacuation routes in case of an emergency (there were no hazards to note) and reminded all those present that mobile phones and internet connections should be switched off and that permission has not been given by the Town Council to permit the recording or broadcasting of the meeting.

- **Minutes of Last Meeting** The Minutes of the meetings held on the 13 November & 20 November 2013 were **RESOLVED** to be a true record of the meetings and were signed by the Mayor.

- **Wadebridge Police** Apologies received report circulated.
- Cornwall Councillor's reports CC Mann had given apologies.
 - CC Knightley addressed the Council on several issues including;
 - i. Planning application for proposed re-development of Wadebridge Football Club specifically concerns with the road layout.
 - ii. Concerns with the location of additional bus stops in Egloshayle Road at roundabout near entrance to West Park.
 - iii. Issues with the timing of works being undertaken by Openreach in Molesworth Street too close to late night shopping event.
 - iv. Notification that driver training for those involved in the new local bus service will not take place until January 2014.
 - v. Innovation Hub meeting at Falmouth University on Monday 16 December.
 - vi. Concerns with parking / traffic at Bridge View junction in relation to the proposed housing development (Members also stated several areas of concern).

RESPONSE IN RELATION TO PA13/10330 & PA13/10331 – Members voiced concerns that the proposed location blocks an historic stained glass window. The application would be supported in an alternative location so as not to block the stained glass window.
